Ban on transfers - instructions thereof.

Sir/ Madam,

I am directed to invite your attention to this Department's letter of even number dated 01-03-2024 on the subject cited above vide which it was conveyed that with effect from 01-04-2024 or from the date of enforcement of Model Code of Conduct, whichever is earlier, the ban on general transfers of employees will again become operative.

2. It is reiterated that the Government has decided to impose a complete ban on transfers' w.e.f. 05-08-2024. It is, therefore, requested that only such proposal of transfers of government employees may be processed and implemented, which are strictly in consonance of circumstances specifically provided under Para 8 of the Comprehensive Guiding Principles-2013, circulated vide O.M. No. Per(AP.B)E(3)-17/20123 dated 10-07-2013 and with the approval of Hon'ble Chief Minister.

3. These instructions may be brought to the notice of all concerned for strict compliance.
