ORDER

The instant dispute had arisen and Complaint was filed by M/s Gables Promoters Pvt. Ltd. Baldeyan, Shimla when Respondent Board HPSEBL had raised Demand of Rs. 40,12,943/- vide Demand Notice dated 21.02.2022 at the behest of RAO Audit which had classified the Complainant under Bulk Supply(BS) tariff. On the last date of hearing, Ld. Counsel for the Complainant M/s Gables Promoters Pvt. Ltd. had placed on record communication by Respondent HPSEBL regarding settlement of disputed amount by Respondent which was to be verified by the Ld. Counsel of Respondent. The Ld. Counsel for Complainant today submitted that the Respondent Board has now allowed sundry credit of Rs.40,12,943/- in favour of the Complainant M/s Gables Promoters Pvt. Ltd., in the electricity bill dated 14.09.2022, earlier raised by Respondent in Demand Notice dated 21.02.2022, thereby settling the matter. The ibid Demand dated 21.02.2022 was raised on account of wrong observation by RAO Audit qua the applicability of Bulk supply(BS) tariff instead of Commercial Supply(CS) tariff and the matter was subsequently taken up with the competent authority. After examining the matter by Respondent, credit of Rs. 40,12,943/- has been allowed in favour of the Complainant. The Ld. Counsel for Complainant further submitted that he is not pursuing the present complaint in view of the above stated facts and prayed to dispose of the same accordingly. In view of the submission made above, the present complaint is disposed of as not pressed for, owing to settlement between the parties.

The Order is released today on 30.09.2022 at Shimla in presence of parties. Certified copies of this Order be supplied to parties The original complaint file along with this Order be consigned to record room for safe custody.
