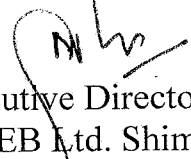

Any negligence and carelessness on this account shall be viewed very seriously please.

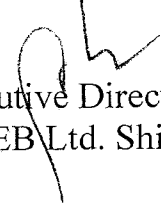
