NOTIFICATION

In exercise of powers conferred by proviso to article 309 of the Constitution of India, the Governor of Himachal Pradesh is pleased to make the following rules further to amend the Supplementary Rules, in their application to the State of Himachal Pradesh, namely :-

Short title and commencement: 1. (1) These rules may be called the Supplementary Himachal Pradesh Amendment Rules, 2023.

(2) They shall come into force from the date of their publication in Rajpatra (e-Gazette), Himachal Pradesh.

Substitution of rule 71

2. For rule 71 of the Supplementary Rules (hereinafter referred to as "said rules"), for the words "eight kilometers", wherever occurring the word "thirty kilometers", shall be substituted.

Substitution of rule 89

3. For rule 89 of the said Rules, the following shall be substituted, namely:-

"A competent Authority may, by general or special order, permit any Government servant or class of Government servants to draw the actual cost of hiring a conveyance on a journey for which no travelling allowance is admissible under these rules.

Amendment of rule 114

4. In rule 114 of the said rules, the following proviso shall be inserted, namely:-

"Provided further that Travelling allowance may also not be drawn under this section by a Government servant if he is transferred in the public interest but within the radius of thirty kilometers from the duty point (i.e. the place/ office of employment) at his headquarters or return to it from a similar point".

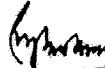

हिमाचल प्रदेश के राज्यपाल, भारत के संविधान के अनुच्छेद 309 के परन्तुक द्वारा प्रदत्त शक्तियों का प्रयोग करते हुए, सप्लिमेंटरी रूलज का हिमाचल प्रदेश में इनके लागू होने पर और संशोधन करने के लिए निम्नलिखित नियम बनाते हैं, अर्थात् :-

- संक्षिप्त नाम और प्रारंभ । 1. (1) इन नियमों का संक्षिप्त नाम सप्लिमेंटरी हिमाचल प्रदेश अमेंडमेंट रूलज, 2023 है ।
(2) ये राजपत्र (ई-गजट), हिमाचल प्रदेश में इनके प्रकाशन की तारीख से प्रवृत्त होंगे ।

- नियम 71 का 2. सप्लिमेंटरी रूलज (जिन्हें इसमें इसके पश्चात "उक्त नियम" कहा प्रतिस्थापन । गया है) में जहां "eight kilometers" शब्द आते हैं के स्थान पर "thirty kilometers" शब्द रखे जाएंगे ।

- नियम 89 का 3. उक्त नियमों के नियम 89 के स्थान पर निम्नलिखित रखा प्रतिस्थापन । जाएगा, अर्थात् :-

"A competent Authority may, by general or special order, permit any Government servant or class of Government servants to draw the actual cost of hiring a conveyance on a journey for which no travelling allowance is admissible under these rules.
