Subject: - Regarding handling of the Court matters/cases in the Ld. Court(s) - Instructions thereof.

Sir,

In connection with the above, it has been noticed by the higher authorities that the court cases are not being assigned due and top priority and the cases are being handled in a casual manner by the Field offices as well as Admn. Section at the Board's Level and even replies are not being filed in a time bound manner before the various levels of the Ld. Courts/ Forums etc., consequently the Ld. Courts are time and again calling the Management of the Board to remain present during the hearing.

It has further been observed that while submitting the cases before the Legal Cell and thereafter before the Ld. Courts/ Forums etc., well conversant officer(s)/ official(s) with the facts of the case are not being deputed and on many occasions it has been noticed that the persons deputed are not in a position to render effective assistance during the legal examination of matters.

It is relevant to mention here that despite clear instructions with regard to the court cases/ legal matters has been issued time and again, but the same are not being followed by the Field Units as well as the Admn. Sections at Board Sectt. level resulting in unwarranted litigation and huge financial loss to the HPSEBL.

In view of above and in order to obviate the above situations, you are once again requested to kindly impart suitable directions to all the Officers under your control at Zone/ Board Sectt. Level (s) that such instances be not allowed to occur in future and timely action be initiated in all the court/ legal matters, besides responsible officers fully conversant with the facts of the case/ matter be present while vetting/ examination of issue together with connected record. The Field Officers/ Heads of Admn. wings at Board's Level are further be advised that henceforth to accord top most priority & due importance to the court cases/ legal matters and cases may be defended/ prosecuted with proper care & caution and not in a casual manner in consultation with the Legal Cell of the HPSEBL.

Now, onwards any lapse thereto shall be viewed very seriously and in case of delay in dealing the court/ legal matters, responsibility should be fixed on the officer(s)/ official(s) who are responsible for the delay as well as for monitoring/ pursuing of the court cases/ legal matters in an effective manner. This is for your information and taking further necessary action in the matter please.

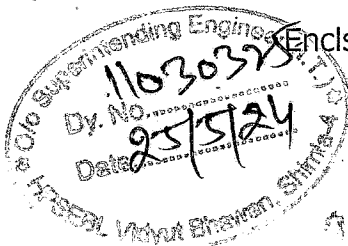

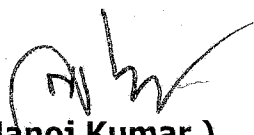
