Interim Order

M/s Shree Parwati Steel and Alloys, Village Kheri, Trilokpur Road, Kala Amb, District Sirmour (HP), bearing Consumer ID 100012002332, has filed a complaint along with an Application for restraining the Respondents/ non- Applicants from the recovery of impugned/disputed amount of Rs. 4,96,000/- raised as sundry by the Respondent in its electricity bill dated 12.06.2023 (Annexure C-1) and from disconnecting the Complainant. The Applicant has expressed apprehension of disconnection by Respondent HPSEBL against non-payment of the ibid amount and prays for restraining the Respondents/ non- Applicants from recovering the ibid amount and from disconnecting the Complainant.

Complaint is admitted. In terms of regulation 25 of the HPERC(Consumer Grievances Redressal Form and Ombudsman) Regulations, 2013, the Complainant is directed to deposit with the Respondent $\frac{1}{3}^{\text{rd}}$ of disputed amount of Rs. 4,96,000/- (Annexure C-1), this amounting to Rs. 1,65,334/-, within a period of 10 days, from today i.e. on or before 03.07.2023. On deposit of this amount, the Respondent is directed to not take any coercive action and also not to disconnect the Complainant.

On failure of the Complainant to pay the ibid Ordered amount of Rs. 1,65,334/- by the said date, the Respondent HPSEBL shall be at liberty to take further action as per extant Regulations.

The Receipt of deposit of the ibid Rs. 1,65,334/- shall be placed on record by the Complainant immediately thereafter, with advance copy to the Respondents.

Registry is ordered to issue Notices to parties. It is seen from record that Complainant has forwarded advance copy of complaint to the Respondent and accordingly Respondent is directed to file Reply in the matter on or before 18.07.2023 Main complaint to come up for Reply on 18.07.2023. Application is accordingly disposed on forgoing terms.
