Special recruitment drive for clearance of backlog and shortfall of Scheduled Castes, Scheduled Tribes, Persons with Disabilities and Other Backward classes in direct recruitment.

Sir/Madam,

Kindly refer to this Directorate letter of even No. dated:- 29th October, 2019, on the subject cited above, vide which, undersigned has requested you to take immediate necessary action for filling up of backlog vacancies reserved for Persons with Benchmark Disabilities (Blind and Low Vision) of Class-III and Class-IV posts. Also, vide letter of even no. dated- 31st July, 2019 undersigned has requested you to take necessary action regarding providing 4% reservation to the PwDs as per the provision u/s 34 of RPwD Act, 2016.

In this context, it is submitted that regarding providing reservation to PwDs as per provision u/s 34 of RPwD Act, 2016, instructions have already issued by the DoP H.P. vide "Office Memorandum" dated- 22-06-2017. Despite detailed instruction queries are being raised by the Departments about the roster point earmarked to PwDs. In this regard, the DoP H.P. has clarified that for providing 4% reservation to PwDs, in 100 point roster the roster point 1,26,52 and 76 has been earmarked to PwDs in Class-I to IV posts in direct recruitment. Further, DoP has clarified that the head of the establishment shall decide the categories of disabilities for which the roster point 1,26,52 and 76 will be reserved keeping in view of all relevant facts.

Also, DoP has clarified that the first roster point shall be reserved for PwDs only in such cadre where the cadre consists of 25 or more posts. The copy of the clarification issued by DoP H.P. is being supplied to you through e-mail and is also available in the official website of this Directorate.

In view of the above, you are, requested to take necessary action regarding identification of posts reserved for Persons with Benchmark Disabilities and thereafter filling up of these posts, under intimation to this Directorate please.
