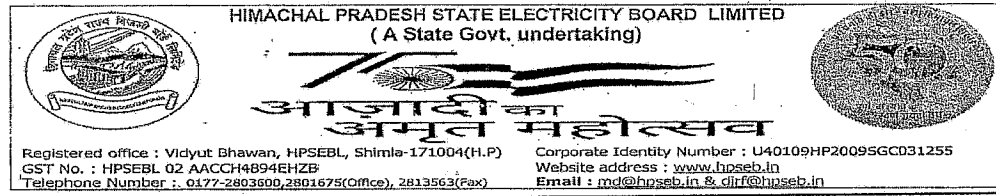

Sir,

Kindly refer to your office letter endst. vide No.ANG/PRESS-PUB-2009 dated 09.06.2022 on the subject captioned above.

In context, it is stated that the competent authority of the HPSEBL had already taken a decision to get the special audit conducted in respect of the payments which are being released by the various DDO's of the HPSEBL to the 'service providers', in view of the instances which have been reported that the service providers, though are released the payments by the DDOs but in turn are not depositing the subscription on account of EPF and ESIC, with the concerned office/authorities for credit in the accounts of out sourced workers.

For the purpose of conducting Special Audit the HPSEBL has already directed its CAO vide letter of even file bearing NO. 15768-69 dated 05.06.2021 to constitute a committee for the purpose in order to find out as to whether the EPF and ESIC subscription of the out sourced workers are being deposited by the service providers in their respective accounts from the date of their initial deployment/engagement by them or otherwise.
