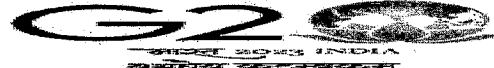

Kindly refer to this office letter No.HPSEBL/Sect/DDP/321-11 (Outsourced)/23-24-45393-413 dated 21.09.2023 on the subject cited above.

In this context, it is intimated that on scrutiny of the information as supplied by your office(s) have not been found in accordance with the prescribed Performa. As per the above Vidhan Sabha question No. (a) It, is clearly mentioned in Colonm No.5 that how much contract amounts being given to the outsourced agency; however, it has been found that there are many discrepancies in the above information with regard to the amounts of Column No-5. and question No. (b) at Column No.6 which clearly says that how many funds had been disbursed to outsource agency/service provider during last 3 years upto 31.8.2023.

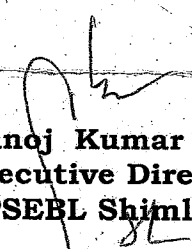
Now, it is intimated that the desired information supplied by your offices are not in line with the prescribed Proforma, therefore, you are once again requested to supply the desired information to this office as per the prescribed Performa (attached). The information in the Proforma may be provided as per the question (a) pertains to columns No. 1 to 5 only. The Column No. 5 clearly says that how much Contract Amounts have been

given to the Outsourced Agency. Although, columns No. 6 to 11 specifically pertains to the question (b) which is regarding M/s Shimla Cleanways and clearly says that how much funds have been disbursed to the outsourcing agency/service provider (i.e. M/s Shimla Cleanways) during last 3 years upto 31.08.2023); the cut of date for the said information may be presumed 01.9.2020 to 31.8.2023 strictly in the case of M/s Shimla Cleanways.

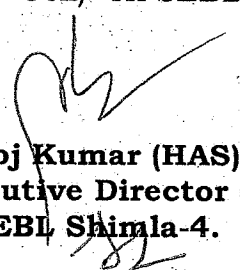
Furthermore, the detail of the outsourced workers engaged through M/s Shimla Cleanways may be provided name wise clearly mentioning the amounts given to each individual.

Being an assembly business the above information may kindly be supplied as a whole wing-wise within week's time positively, without fail, through **E-mail i.e. deputydirectorpers@gmail.com** so that the above information can be submitted to the Vidhan Sabha accordingly. The matter may be given top priority and any laxity in this matter to be viewed seriously and stringent action will be initiated against the erring officer/official by competent authority of the Board
