2. Latest Nakal pariwar register & consent/willing for Class-IV (Non-Technical Post on daily wages basis.

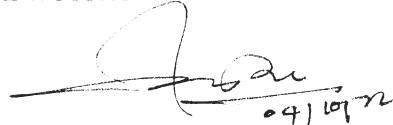
