OFFICE ORDER

Subject: - Grant of Dearness Relief to Himachal Pradesh State Electricity Board Limited Pensioners/family Pensioners-Revised rate effective from 01.07.2021.

In continuation to this office order endorsement No. HPSEBL (SECTT) R&E/6-156/ 2020-87785-88030 dated 21.03.2020, the Himachal Pradesh State Electricity Board Ltd., is pleased to decide that dearness relief payable to the HPSEBL Pensioners/Family Pensioners shall be enhanced from existing rate of 153% to 159% w.e.f. 01.07.2021 to the HPSEBL Pensioners/Family Pensioners.

2. Payment of Dearness Relief involving a fraction of a rupee shall be rounded off to the next higher rupee.
3. Other provisions governing grant of dearness relief to pensioners such as regulation of dearness relief during employment/re-employment, regulation of dearness relief where more than one pension is drawn etc. will remain unchanged.
4. As dearness relief will now be at a uniform rate, it has been decided to dispense with the issue of enclosing ready reckoner alongwith the dearness relief orders. It will be the responsibility of the Pension Disbursing Authority, (PDA) including the Nationalized Banks, etc. to calculate the quantum of dearness relief payable in each individual case.
5. The additional Dearness Relief shall be paid with the pension/family pension for the month of September, 2021 payable in the month of October, 2021. The arrears accrued on account of dearness relief w.e.f. 1.7.2021 to 31.8.2021 shall be paid in one installment along with the pension /family pension for the month of September, 2021 payable in the month of October, 2021.
