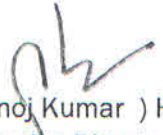

It is however clarified that no Reservation for persons with benchmark disabilities be considered for appointment of above categories, as the Govt. of Himachal Pradesh vide its office memorandum dated 22nd June, 2017 has already granted exemption which had adopted by the HPSEBL vide office order endorsement No. HPSEBL (SECTT.)/R&E//14-2/2018-85039-319 dated 05-03-2018.

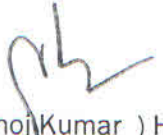
The above committees will submit its report to this office within 5 day's positively, so that the report /recommendation could be placed before the competent authority for consideration and decision.
