Matter was listed today for the first time for admission hearing.

Both parties are present today and have briefly explained the matter to the Forum.

In the matter, Forum observes that Registry of the Forum has issued Notice to the parties on 22.12.2025. Against observation No.4 of this Notice, the Ld. Counsel for Complainant has submitted some documents and seeks some more time to address other observations at Sr. No.1, 2 &3.

In the meantime, Ld. Counsel for Complainant prays for interim relief against Demand Notice issued by Respondent No.4, which is placed in complaint at Annexure C-2. Ld. Counsel for Complainant pleads that in the event that if this interim relief is not granted against Application also filed along with complaint, then coercive action may be taken against it by Respondent.

Forum from perusal of Regulations finds that in accordance with Regulation 25 of the HPERC (CGRF & Ombudsman Regulation 2013), the pre-condition for

allowing the interim relief is the deposit of 1/3rd of disputed amount.

Ld. Counsel for Complainant states that it is willing to deposit the statutory 1/3rd of disputed amount.

However, Forum on going through Demand Notice (Annexure C-2) finds that Respondent No.4 has failed to specify any disputed amount in this Demand Notice.

In view of foregoing, Respondent No.4/ Respondent No. 3 is directed to revise and issue to Complainant within 10 days, a revised Demand Notice dated 10.12.2025 (Annexure C-2) by specifying therein the outstanding amount payable by Complainant.

Respondent is directed to place on record of the Forum on the next date, the said revised Demand Notice.

Till such time, Forum finds that it is unable to pass any Order regarding deposit of said 1/3rd amount as specified under Regulation 25.

However, till the next date, Respondent is directed to not take any coercive action against the Complainant.

The next date in the matter shall be intimated to the parties through separate Notice.
