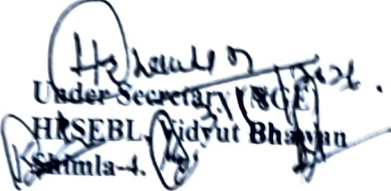

The Controlling Officer(s) shall ensure that the above named officials are relieved immediately enabling them to join at the new place of their posting on promotion. Their relieving should not be delayed on any pretext unless the official(s) voluntarily forego(es) the promotion and give(s) the request to this effect in writing which may be forwarded to this office without any delay and take necessary action to withdraw the promotional increments granted to him/her on completion of 23 years of service and **no extension in joining time shall be granted.**

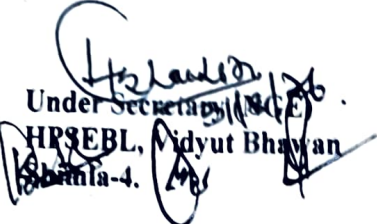
