O R D E R

WHEREAS, the petitioner, **Er. Shiv Kumar, Assistant Engineer (Electrical)**, presently posted in the Office of Electrical Sub-Division Killar (Pangi), filed **CWP No. 11383 of 2026**, titled *Shiv Kumar vs. HPSEBL Ltd. & another*, before the Hon'ble High Court of Himachal Pradesh seeking his transfer from the tribal area to a station of his choice.

AND WHEREAS, vide judgment dated **10.07.2026**, the Hon'ble High Court disposed of the writ petition with directions to the Competent Authority to consider and decide the petitioner's representation dated **25.05.2026** within eight weeks and, if the petitioner had completed the normal tenure in the tribal area, to post him outside the tribal area at a suitable station of his choice, subject to administrative feasibility.

AND WHEREAS, in compliance with the aforesaid directions of the Hon'ble High Court, the representation of the petitioner has been examined in the light of the relevant records, the prevailing Transfer Policy, and the comments furnished by the concerned administrative authorities.

It is observed from the records that the petitioner joined the Office of Electrical Sub-Division Killar (Pangi), on **27.07.2020** on contractual appointment and has been serving at the said tribal station continuously. His services were subsequently regularized with effect from **01.04.2022**. His present place of posting falls within the notified tribal area where the prescribed normal tenure is three summers and two winters.

The competent administrative authority has confirmed that the petitioner has completed the prescribed normal tenure in the tribal area and is, therefore, eligible to be considered for transfer to a station of his choice in terms of the prevailing Transfer Policy, subject to administrative exigencies and availability of vacancy.



AND WHEREAS, it has further been observed from the records that **Er. Mukesh Kumar, AE(Elect.)**, has been posted in **Electrical Sub-Division No. II, Nalagarh**, since **17.05.2022** and has completed the prescribed normal tenure at the said station. Accordingly, the adjustment of the petitioner against the said longer-stayee is considered administratively feasible. The proposed adjustment is in consonance with the prevailing Transfer Policy as well as the directions of the Hon'ble High Court. Accordingly, after due consideration of all relevant facts, records, and administrative requirements, the Competent Authority is satisfied that the petitioner's request deserves to be accepted.

NOW THEREFORE, The representation dated **25.05.2026**, stands disposed of accordingly in compliance with the judgment dated **10.07.2026** passed by the Hon'ble High Court of Himachal Pradesh in **CWP No. 11383 of 2026**. Accordingly, **Er. Shiv Kumar**, Assistant Engineer (Electrical), is hereby transferred from the Office of Electrical Sub-Division Killar (Pangi) to Electrical Sub-Division No. II Nalagrah, against **Er. Mukesh Kumar, AE(Elect.)** on vice versa with immediate effect. Both shall be entitled to TTA/JT, as admissible under the applicable Rules.
