For recruitment to these posts, the requisite Education and other qualification shall be Matric pass from a recognized Board of school Education and must possess valid driving license for plying of heavy/light Vehicles in hilly terrain and applicant should be between 18 to 45 years of age as on **01-04-2021** and upper age relaxation is

available to Ex-serviceman candidates of HP. as per provision of relevant rules/instructions of the GOHP in force.

It is however clarified that no Reservation for persons with benchmark disabilities be considered for appointment of above categories, as the Govt. of Himachal Pradesh vide its office memorandum dated 22nd June, 2017 has already granted exemption which had adopted by the HPSEBL vide office order endorsement No. HPSEBL (SECTT.)/R&E//14-2/2018-85039-319 dated 05-03-2018.
