ORDER

The matter came up for arguments/final hearing today. The Complainant M/s I.D. Sood, ISPAT Private Ltd., Vill.& P.O. Kandrori, Tehsil Indora, Distt. Kangra, filed the Rejoinder which is placed on record. The Complainant by way of Rejoinder placed on record, has brought the fact of CWP No.5537/2022 (HPSEB) and Others v/s M/s I.D. Sood Ispat Pvt. Ltd. and Others which has been filed before the Hon'ble H.P. High Court and is pending adjudication. The Ld. Counsel for the Complainant has also submitted that said writ is listed for hearing on 05.04.2023.

At this stage, Complainant prayed to allow withdrawal of present complaint preferred before this Forum with liberty to approach the appropriate Forum for redressal of grievance if any, after matter is decided by Hon'ble H.P. High Court. The complainant further sought liberty to deposit 1/3rd amount of bill dated 24.08.2022 raised for a demand of Rs. 65,81,612/-, which amounts to Rs. 21,93,871/-, so as to establish the bona-fide of complainant to settle the genuine amount of demand notice (Annexure C-1).

After hearing and perusal of the documents/record the prayer of the Complainant is allowed. The instant complaint preferred by the Complainant is dismissed as withdrawn; with a liberty to approach appropriate Forum for redressal of grievance if any. Further the complainant is also at liberty to deposit 1/3rd amount of the demand raised through the bill dated 24.08.2022 for Rs.65,81,612/-(Annexure C-1) i.e. amounting to Rs.21,93,871/- with the Respondent Board as prayed above. The Respondent HPSEBL to allow the Complainant to deposit the ibid 1/3rd amount of Rs.21,93,871/- of the demand raised through bill dated 24/08/2022 referred above in consequence of the order.

The Order announced today on 09.01.2023 at Shimla in presence of parties. Certified copies of this Order be supplied to the parties. The original complaint file along with this Order be consigned to record room for safe custody.

Parties are left to bear their own costs.
