The controlling officer shall ensure that the officer is relieved immediately unless the officer voluntary forgo(s) the promotion and give the request to this effect in writing which may be forwarded to this office without any delay.

In case at any stage the post(s) of Sr. Executive Engineer (C/M) becomes excess due to repatriation or any other reason in the HPSEBL, the junior most incumbent(s) shall be reverted. The officer in whose case change of station is involved will be entitled to usual TTA & joining time as admissible under rules & no extension in joining time will be granted.

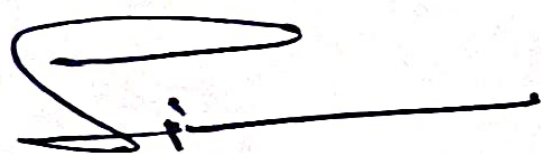
The promotion of the above officer will be subject to the outcome of CWP No.262 of 2022 titled Rattan Jeet & Ors. Vs HPSEBL.
