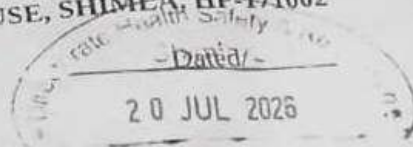

OFFICE ORDER



In pursuance of the provisions of policy for empanelment and reimbursement claim Notified vide Notification No. HFW-B (F)2-10/2018, dated 16/01/2021, by the Govt. of Himachal Pradesh M/s Navkiran Eye Hospital, Phase 3, New Nalagarh, Distt. Solan HP 174101 is empaneled for reimbursement of expenses to the Govt. employee's pensioners and their dependents, for specialized medical treatment and diagnosis as listed below, for a period of **one year** as per the terms and conditions mentioned below:-

The empanelment is subject to the following conditions:-

1. The issues related to empanelment and Medical Reimbursement claim to H.P. Government employee pensioners and their dependents shall be governed under the policy notified in this regard by the Govt. of Himachal Pradesh vide Notification No. HFW-B(F)1-1/2008 dated 21/06/2008, 13/02/2012 and guidelines of Single Window Empanelment Policy 2021, notification No. HFW-B(F)2-10/2018-II-Loose dated 31.07.2024 and instructions issued hereunder from time to time.
2. The agreement will be treated as cancelled automatically on:-
 - i) Non Production of Clinical Establishment Certificate beyond 25.11.2026.
 - ii) Non Production of No Objection Certificate from Pollution Department beyond 31.03.2027.
3. These orders shall remain in force for a period of **one years**, subject to the fulfillment of terms and conditions of the MoU by the institution concerned.
4. During the empanelment period, the inspection team from the State or the District may visit the empanelled institutions and if the institution is not found to have services as per the parameters fixed by the Ayushman Bharat-Pradhan Mantri Jan Arogya Yojna (AB-PMJAY), & State Government Medical Reimbursement Policy 2008, the empanelment shall be withdrawn.
5. That there is no dispute, litigation and controversy pending in any Court or office as regard the said hospital, which could jeopardize or adversely affect the interest of the patients care at large and the medical reimbursement process. In case any discrepancy is found at any point of time it would lead to cancellation of empanelment without further notice/reason.

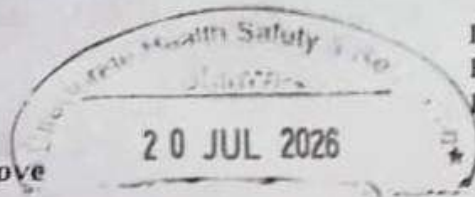

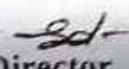
