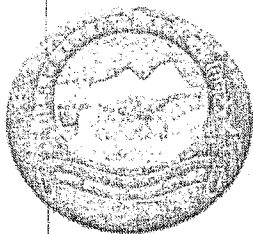

OFFICE ORDER

Subject:- Deletion of the "Arbitration Clause" and "any reference to arbitration" and Constitution of the Departmental Grievance Redressal Committee.

The "Arbitration Clause" and "any reference to arbitration" in all the contracts/bidding documents in HPSEBL, which are to be executed in future except for the Projects/Contracts granted by the funding agency/Government of India, where they prescribe their own SBD is deleted with immediate effect and shall be substituted with following clause:-

"All disputes or differences in respect of which the decision, if any, of the Project Manager and/or the Head of the Implementing Authority has not become final or binding as aforesaid shall be settled by Departmental Grievance Redressal Committee constituted as under:

In case, the claim/representation made by the aggrieved parties is found genuine, in that eventuality, the Department Grievance Redressal Committee shall recommend the claim through Chief Engineer (MM) to the WTD of HSPEBL including Chief Engineer (concerned) & Deputy Secretary (Law) as special invitees for approval.

In case of any dispute/difference further arising out of said contract, the same shall be subject of jurisdiction of Civil Court within the territory of Himachal Pradesh."
