ORDER

The matter came-up for argument/disposal. The complainant today submitted that the Respondent HPSEBL has credited/refunded the excess consumption rebate for night consumption and peak hours' consumption by way of adjustment in its energy bills. The complainant in its statement filed on 25.02.2021 has also categorically confirmed and admitted the said refund of Rs.28,82,080.90 in its Para 3. The complainant also stated that the refund of Rs. 28, 82,080.90 also include the interest etc. Nothing survives now in present complaint after the above referred refund credited in energy bills of complainant by Respondent. The complainant prayed to dispose of the complaint accordingly.

In view of the statement of the complainant recorded above and the settlement made by the Respondent HPSEBL by way of credit of refund in energy bill of complainant company of an amount Rs. 28,82,080.90 (Twenty Eight lakh Eighty two Thousands and Eighty and Paise Ninety only). The present complaint is closed, as nothing survives now after reconciliation and confirmation by the complainant. Announced before the parties present at Shimla today on 24.3.2021. Parties are left to bear their own costs.
