Subject:- Option for appointment as Non-Technical Class-IV under Compassionate grounds under Employment Assistance policy-Extension of date.

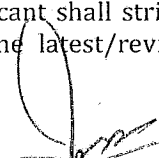
I am directed to say that the HPSEBL vide office order bearing No. HPSEBL (Sectt.)/ R&E/14-2/ (EAS) 2021 -79774-80024 Dated 19.02.2022 has adopted the instructions contained in office memorandum issued by the Special Secretary (Finance) to the Govt of H.P vide No. Fin-F (A)-16-1/2013 dated 24th January. 2022 regarding providing employment under Compassionate Employment policy as Class-IV (Daily Wages) posts in HPSEBL and the same operation has been closed on 15.04.2022, shall be applicable w.e.f 16.04.2022 vide office Memorandum No. Fin-F-(A)-16-1/2013-I Dated 30.03.2022. Now the Govt. of H.P instructions issued vide office Memorandum of even number dated 24th January, 2022 **to extend the aforesaid instructions of Finance Department dated 24.01.2022 till 31.08.2022** and the position prevailing prior to issuance of the Finance Departments instruction/relaxation dated 24.01.2022 shall be applicable w.e.f 01.09.2022 in the department.

At present many cases under Compassionate Employment Policy pertaining to different offices are pending of Class-III/IV (Technical) posts in HPSEBL. Since the Govt. of H.P vide notification referred as above has decided to provide employment under Compassionate Employment policy in non-technical Class-IV (Daily wages) and the applicants who have applied for Class-III /Class-IV (Technical) posts have to opt for non-Technical Class-IV (Daily Wages) posts, as the quota for Class-III/Class-IV (Technical) posts under EAS Policy, stands already exhausted and no post of Class-III/Class-IV (Technical) is available with HPSEBL under this policy. Therefore, all the concerned Chief Engineers are requested to obtain an option/willingness from individuals concerned, **who has not previously opted the option/consent to the Class-IV post (Non-Technical) and those applicants who has applied after 15.04.2022,** (On the consent/ willing proforma previously already enclosed) from the eligible candidates whether they are willing to accept an offer of appointment as Non-Technical (Class-IV) (Daily Wages) or otherwise, along with related documents issued by the competent authority and thereafter send the same to this office on or before 26.08.2022 up to 5.00 PM without fail as time bound manner, and extended aforesaid instruction relaxation till 31.08.2022 only. Any delay in furnishing the documents/option shall be the personal responsibility of the erring officer/official. The applicant concerned may be informed that his

claim for Class-III /Class-IV (Technical) post would be ceased on his appointment to the post of non-Technical Class-IV (Daily wages).

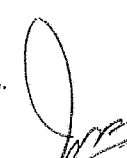
1. Latest Marriage Status of the daughter of the deceased employee who has applied for appointment on Compassionate Employment Policy will also eligible for compassionate appointment, in case the family of the deceased Government employee has only daughter (s) and none in both the families i.e her parental family and the family into which she is married, are in an employment, funded by the Government. As regard income criteria for married daughter (s), income of the parental family will be taken into account of determine indigency, and also required the Income Certificate and Non-Employment Certificate of the both family as per subject to the conditions.
2. Latest Income Certificate issued by the competent authority i.e income from pension and other sources. (The eligible income criteria is Rs. 62500/- per family member of the deceased employee subject to maximum 4 (Four) Legal Heirs.
3. Non Employment Certificate, whether any other family member of the deceased employee, is employed in Govt./ Semi Govt. job from the date of application for appointment on compassionate ground till date.
4. Consent/Willingness/ Option of the applicant for opting non-technical Class-IV (Daily Wages) post instead of Class-III post.

The selection/ appointment of the applicant shall strictly be subject to the final scrutiny of the documents/record as per the latest/revised Employment Assistance Scheme of GoHP.
