Sir,

It is submitted that there are around 3000 workers deployed by the service providers in the HPSEBL who are performing the duties in different capacities in various of HPSEBL and their wages including EPF/ESIC subscriptions were being released by the concerned DDO's time to time to make the payment of wages and deposition of EPF/ESIC subscriptions in the account of each individual worker through concerned service providers.

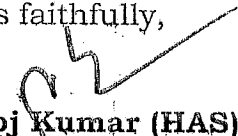
Previously a news was published in the leading news paper i.e "Punjab Kesari" under the head that there is a scam of more than Rs. 200 crore with regard to non-deposition of EPF & ESIC subscriptions of the outsourced workers by the service providers despite of making the payment to them time to time.

The HPSEBL has constituted a Special Audit committee to find out as to whether EPF & ESIC subscription are being deposited by the service providers in the account of each individual outsourced workers. Now the above committee has submitted its report.

The report was put-up to Competent Authority for consideration and it is decided by the Competent Authority to request Dy. Director (ESIC) for taking necessary action against the defaulting service providers/firms. HPSEBL is also taking acting at its own level also. List of such firms with complete detail is enclosed herewith for your information and necessary action please.

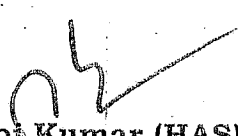
