The seniority of the above named officer in the grade of Under Secretary will be fixed later-on.

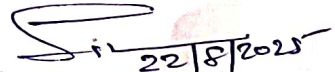
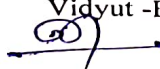

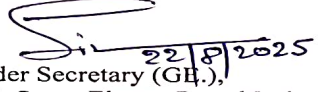
