ORDER

The complaint was first taken-up for hearing today at 11:30AM. None appeared for the complainant and the same was deferred and taken-up for hearing at the end of the cases i.e. at 12:30PM. Again none appeared for the complainant. The conduct of complainant clearly reflect that the complainant is not interested in pursuing the complaint to it's logical conclusion. The record on the case file clearly shows that complainant has sought five adjournments since 21.09.2021 i.e., after filing the Rejoinder. The Respondent Board also pressed for ex-parte hearing today, as the matter has been considerably delayed.

The present complaint has been filed on 19/02/2021 and the parties have filed the respective reply and Rejoinder thereof. The complainant has been afforded ample opportunities to argue the case as is evident from record. The complainant sought five adjournments for the same, since 21.09.2021 and finally the case came up for hearing today. The complainant failed to appear today without any intimation to the Forum despite knowledge. No leave of absence has either been sought from the Forum by the complainant. It appears from the conduct of the complainant that he is not interested in pursuing the present complaint to its logical end. The Respondent Board also pressed for ex-parte proceedings today qua the complainant, as the same has been delayed considerably.

In view of the submissions and observations made here-in-above, and the conduct of the complainant to seek frequent adjournments on one pretext or another as recorded above, the Forum is convinced and of the opinion that complainant is not interested in pursuing the present complaint. The complaint is proceeded ex-parte today. Since the matter has been delayed considerably, thus it would be just and proper that the present complaint be dismissed for reasons of non-prosecution by the complainant. Accordingly the present complaint is dismissed in default for non-prosecution by the complainant.

The parties are left to bear their own costs.
