ORDER

Complaint has been filed by M/s Aggarwal Steels Pvt. Ltd. Patch No.1 & 2 Phase II, Industrial Area Gowalthai Distt. Bilaspur, bearing consumer ID 100012006300.

Matter was listed today for admission hearing. Authorized Representative of Complainant informs that the matter/dispute is with regard to levy of tariff different from what is being presently charged. The Complainant also informs that the instant matter is not with regard to contravention of Tariff Orders under section 142 of the Act.

Forum observes that the matter is with regard to interpretation of Tariff Orders passed by the Ld. HPERC in accordance with notified Regulations, wherein these Tariff Orders are passed by the Ld. HPERC under Sections 62/64 of the Electricity Act, 2003.

In view of the stated position of law, The Forum holds that present dispute/complaint is not maintainable before this Forum for the simple reason that it not vested with any authority and jurisdiction to interpret tariff/ Tarrif Orders passed by the Ld. HPERC.

Accordingly, the complaint is dismissed without going into its merits as not being maintainable before this Forum.

Parties are left to bear their own costs.

Order is passed before the parties present today on 05.09.2023 at Shimla in the open Forum.
