Regarding review of previous decisions-instructions thereof.

I am to refer to the subject cited above and to say that the Hon'ble Chief Minister has directed to take immediate steps to comply with the following decision:-

1. All extensions or re-employments accorded and operative, be terminated forthwith except for Government Medical Colleges.
 2. Decisions taken by the Cabinet since 1st April, 2022 will be reviewed. All institutions for which notifications for creation/up-gradation have been issued, be de-notified. Thereafter, Administrative Departments may put up for fresh consideration of the Cabinet, such proposals which are justified.
 3. Appointments of Chairman, Vice-Chairman and nominated Members in Boards and Corporations, Cooperative Institutions and other Committees including Temple Committees and ULBs be terminated forthwith.
 4. All recruitment processes underway in Departments, Boards/Corporations and autonomous bodies of the State Government, including Public Universities, except those being undertaken through the HP Public Service Commission and HP Subordinate Services Selection Board, be kept in abeyance. This would however not apply to the recruitments being made for Medical colleges and other Institutions of Health Department.
- Status quo be maintained in respect of those transfer orders which are unimplemented.

You are, therefore, requested to take further necessary action in the matter expeditiously.
