The official(s) in whose case(s) the change of station is involved shall be entitled for usual Joining Time & TTA as admissible under the rule.

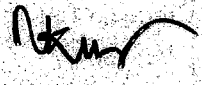

Their relieving should not be delayed on any pretext unless the official(s) voluntarily forego(es) the promotion and give(s) the request to this effect in writing which may be forwarded to this office without any delay and take necessary action to withdraw the promotional increments granted to him/her on completion of 23 years of service and no extension in joining time shall be granted.

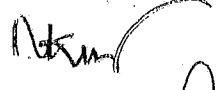
