It has also been observed that the field units are not following the EAS policy of HPSEBL properly for providing Compassionate Employment circulated vide this office order endst No.HPSEBL(SECTT)/R&E/14-2(EAS/2017:-131338-19136 dated 20-05-2017 and further amended vide O/O endst. No.HPSEBL(SECTT)/R&E/14-2(EAS/2019:- 84880-85100 dated 12.03.2020. This has been viewed very seriously by the Board Management.

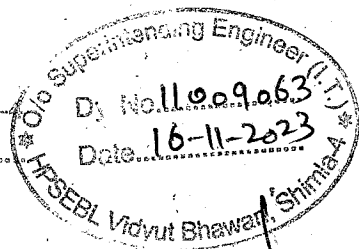
