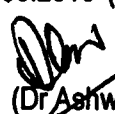

Short title and
Commencement

1. (1) These rules may be called the Business of the Government of Himachal Pradesh (Allocation) Rules, 1971 (155th Amendment) Rules, 2019.

(2) These rules shall come into force from the date of publication in the Rajpatra (e-Gazette), Himachal Pradesh.

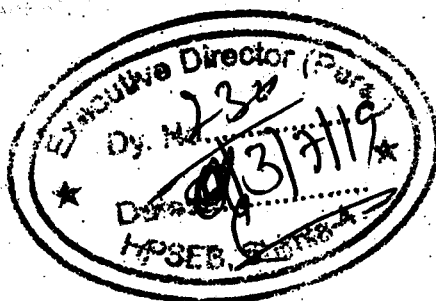
Amendment of the

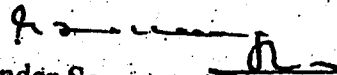
