Subject: Regarding furnishing of information of Outsourced workers with regard to deduction of EPF & ESIC subscriptions.

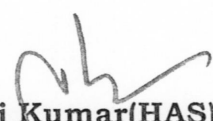
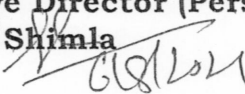
Sir,
