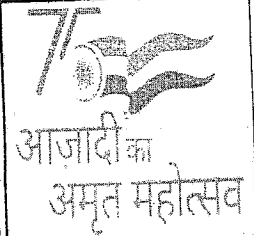

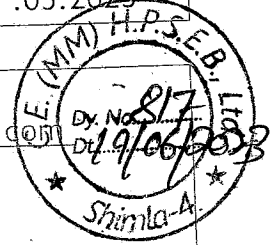

MGVCL has issued LOA to your firm M/s Rao Construction and General Supply on dated 13.7.22 for Empanelment of Vendors for Design, supply, erection, testing and commissioning including warranty, Comprehensive operation & maintenance of Grid-Connected Rooftop Solar Plant of various capacities under the Phase-II of Grid Connected Rooftop Solar Scheme of MNRE /SURYA Gujarat Scheme in the State Gujarat during the

Year (2021-22) for Residential Consumers in Rural Area vide letter at Ref.(6) above under ref tender.

Vide letter at ref no (7), your firm had replied that "M/s Rao Construction and General Supply will not be able to work for Rural area" and requested to accept resignation / withdrawal from said tender and cancel LOA.

Against this reply, vide letter at ref no (8) MGVCL had replied to your firm that clause no 28 n) 39.2.4 and 28 n) 39.3.4 of the tender notice of the tender is applicable to your firm.

As per the terms of LOA the security deposit is to be paid within 30 days from the receipt of LOA and an agreement is to be executed separately on given date of intimation or within 03 days from the intimation date. But after issuing LOA, your firm had not paid SD and not executed an agreement after passing 30 Days of LOA date.

Notice at Ref.(10) have been issued to your firm for execution of an agreement against LOA and also to pay Security Deposit. In reply vide letter at ref no (10), your firm had shown unwillingness to continue with tender.

A reminder and Final notice also has been issued to M/s Rao Construction and General Supply vide letter at Ref. (13) & (15) respectively to pay required security deposit as mentioned in LOA and execute agreement with given sufficient time i.e. up to 22.11.2022. But your firm have neither paid security deposit amount nor executed an agreement.

After accepting all Term & Condition of online Tender No. 1227 for Empanelment of Vendors for Design, supply, erection, testing and commissioning including warranty, Comprehensive operation & maintenance of Grid-Connected Rooftop Solar Plant of various capacities under the Phase-II of Grid Connected Rooftop Solar Scheme of MNRE /SURYA Gujarat Scheme in the State Gujarat during the Year (2021-22) for Residential Consumers in Rural Area, is adversely affecting image of all DISCOMs of Gujarat including MGVCL to achieve the targets decided by Government. Thus, failure on your part to accept LOA is nothing but a breach of Tender terms and conditions.

In view of failure on your part to pay required security deposit and execute an agreement, a show cause notice was issued to your firm on dated 12.12.22 stating that *"why action like Forfeiting the EMD, stop dealing with you / your firm etc. and/or any other actions as decided by MGVCL competent authority; may not be initiated against you / your firm."*

M/s Rao Construction and General Supply was informed to submit reply within 15 days from the date of receipt of this show cause i.e. on or before 23.12.2022, In reply, your firm replied that firm cannot accept the conditional LOA in rural tender 1227 which is not acceptable as per tender terms and conditions.

Hence, looking to all the above facts, it is concluded that MGCVCL has given enough/sufficient chance/time to your firm to pay required security deposit mentioned in LOA and execute agreement but you have totally failed to pay required security deposit and execute agreement against LOA placed.

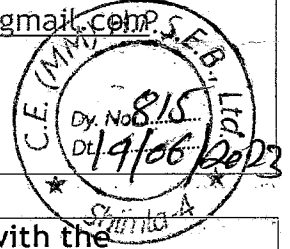
