ORDER

In continuation of the Orders of even number dated 05.01.2022, 08.01.2022, 09.01.2022, 13.01.2022 and Corrigendum dated 14.01.2022 that were issued by the State Executive Committee (SEC) for effective control of COVID-19 in the State. Taking note of the present situation of COVID-19 in the State, the undersigned in the capacity of the Chairman (SEC) in exercise of the powers conferred under section 22(2)(h) and section 24 of the Disaster Management Act 2005, hereby directs that, directions issued by SEC in above mentioned orders will continue to remain in effect till 6AM of 31st January 2022.

For Himachal Pradesh Statehood Day (25th January) and Republic Day (26th January) related programs scheduled in the districts, the limit for gatherings in open spaces/outdoor areas is however allowed up to 50% of the capacity ensuring strict adherence to the COVID-19 safety protocols and COVID Appropriate Behaviour.

All the Departments and Organisations of the Government, District Magistrates, Police Officers/Officials and Local Authorities of the State are directed to ensure strict compliance with the directions of the SEC ibid.

Penal Provisions:

Any person violating these measures and not following COVID appropriate behavior will be liable to be proceeded against as per the provision of Section 51-60 of the Disaster Management Act, 2005, besides entailing legal action under Section 188 of the IPC, and other legal provisions as applicable.

This Order shall remain in force, in all parts of the Himachal Pradesh till 6 AM of 31 January 2022.

ORDER

Whereas, orders of even number dated 05-01-2022, 08-01-2022 and 09-01-2022 were issued by the State Executive Committee (SEC) for effective control of COVID19 in the State.

Whereas, considering the recent surge in COVID-19 cases across the State and after considering the current situation of the COVID-19 pandemic which requires strict measures in order to contain its spread.

Therefore, in exercise of the powers conferred under the Section 22(2)(h) and Section 24 of the Disaster Management Act 2005, the undersigned in the capacity of the Chairman, State Executive Committee (SEC), hereby directs that the following exemption shall be in force in addition to the directions already issued by SEC vide order dated 05-01-2022, 08-01-2022 and 09-01-2022 in Himachal Pradesh:

- **Persons with disabilities and pregnant women employees shall be exempted from attending office but are required to work from home.**

This Order shall remain in force, in all parts of the State with immediate effect till 6AM of 24th January 2022 or further orders, whichever is earlier.
