Subject:- Requisition for filling up of 22 posts of Electrician (PHE) Post Code-974 on contract basis in HPSEB Ltd. CE (Gen.) wing Sundernagar, recommendation in compliance to judgment dated 03.03.2025 passed in CWP No. 14724/25 titled as Virender Singh V/D HPSSC & Ors.

In connection with the above, please find enclosed herewith the list of candidates selected from Waiting Panel-II, as received from the Himachal Pradesh Public Service Commission (HPPSC), Shimla, for their appointment to the posts of Electrician (PHE) on a contract basis in the HPSEB Ltd. and approval thereof.

1. In this regard, it is stated that the HPPSC, vide its letter dated 25.03.2025, has recommended the names of three candidates from the order of merit from the waiting panel for appointment to the post of Electrician (PHE), Post Code-974, on contract basis in HPSEB Ltd., in compliance with the judgment dated 03.03.2025 passed in CWP No. 14724/2025, titled *Virender Singh vs. HPSSC & Ors.*

2. In view of the above, it is requested to issue appointment letters to the selected candidates on contract basis for a period of one year, as per the Recruitment and Promotion (R&P) Rules, after constituting a Screening Committee under the Chairmanship of the concerned Superintending Engineer(s) to scrutinize the documents of the selected candidates.
3. The candidates shall be appointed on fixed monthly contractual emoluments, which shall be 60% of the first cell of the applicable Level-4 pay matrix (₹23,500–74,300), as per the revised pay scale notified vide Office Order No. 1/HPSEBL(Sectt.)/2022 dated 12.04.2022, endorsed vide No. HPSEBL(Sectt.)/SA-Scale-1(Regulation)/2022-2875-3095 dated 12.04.2022. This is in accordance with the contract appointment policy of the Government of Himachal Pradesh, duly adopted by HPSEBL.
4. The original application forms, along with photographs and self-attested copies of documents (educational qualifications, Himachali certificate, SC/ST/OBC certificates, etc.) submitted by the candidates at the time of documentation, are enclosed herewith. These are to be retained in the personal files of the candidates by the Head of Office.
5. The offer of appointment may be issued only after verifying the documents/credentials and completing all other codal formalities to the satisfaction of the appointing authority. In case of any discrepancy, misrepresentation or fraud, the offer of appointment may be withheld, and the matter may be reported to this office.

6. Candidates who have submitted provisional certificates of technical qualifications are required to submit their final Diploma/Degree certificates within one year from the date of joining. Failure to do so shall result in termination of contractual services without notice.
7. The names of candidates who do not join the post within the stipulated time period may be immediately intimated to this office for further necessary action.
