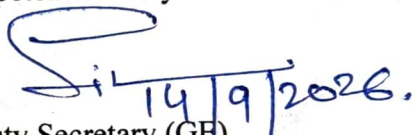
The officers in whose case(s) change of station is involved will be entitled for usual TTA & Joining time as admissible under the rules.

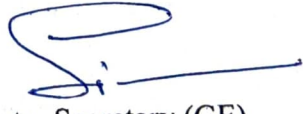
