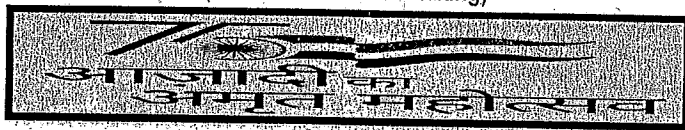

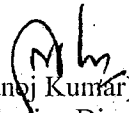
The official(s) in whose case(s) the change of station is involved shall be entitled for usual Joining Time & TTA as admissible under the rule.

All the above named officials on their promotion shall join at the places of their postings as above **within ten days positively, thereafter they will be deemed relieved.**

The Controlling Officer(s) shall ensure that the above named officials are relieved immediately enabling them to join at their new place of posting on promotion within ten days positively. Their relieving should not be delayed on any pretext unless the official(s) voluntarily forego(es) the promotion and give(s) the request to this effect in writing which may be forwarded to this office without any delay and take necessary action to withdraw the promotional increments

granted to him/her on completion of 23 years of service and no extension in joining time shall be granted in future.

Note: - All the controlling officers before relieving the above promotee officials shall ensure that no Vigilance case is pending/being contemplated against them, if so, matter be reported to this office and the official may not be relieved.

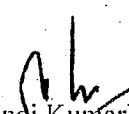
