ORDER

WHEREAS the petitioners, Sh Roop Lal S/o Shri Krishan Dayal R/o Vill. Patta, P.O. Kallar, Tehsil and District Bilaspur HP and others have filed a CWP No. 14569 of 2025 titled as Sh. Roop Lal and others vs HPSEB Ltd. and others before the Hon'ble High Court of HP at Shimla praying therein for the following reliefs:-

- I. That a writ in the nature of Mandamus may very kindly be issued directing the respondents to give postings to the petitioners against the vacant posts in Electrical Division HPSEBL, Bilaspur and Ghumarwin being Class-IV employees of the respondent Board.**
- II. That a writ in the nature of Mandamus may very kindly be issued directing the respondents to release the salary of the petitioners for the months of July, and August, 2025 etc. etc.**

AND WHEREAS the Writ Petition aforesaid came up for hearing before the Hon'ble High Court of HP at Shimla on 09-09-2025, when the Hon'ble Court has been pleased to issue the following directions as under:-

Notice. Mr. Anil Kumar, Advocate, appears and waives service of notice on behalf of the respondents. He prays for and is granted one week's time to file short reply. Needless to say, salaries of the petitioners, if not already paid for the month of July and August, 2025 as alleged, shall be released on or before the next date of hearing. List on 19.09.2025.

In compliance with the directions passed by the Hon'ble High Court of Himachal Pradesh dated 09.09.2025, the salary of the petitioners for the months of July and August, 2025 has been released on 17.09.2025, and the same has been duly credited to their respective bank accounts.

The competent authority of the Board has also observed that the office of the Superintending Engineer, M&T Circle, HPSEB Ltd., Bilaspur, was disbanded vide office order dated 22.02.2025 with immediate effect. Consequent upon this disbandment, seven posts of various Class-IV categories were diverted to the surplus

pool of the Board, with the stipulation that such surplus staff would thereafter be transferred and adjusted against vacant posts in needy units of the Board. In light of the above, the competent authority of the Board had forwarded the case file to the Government of Himachal Pradesh for approval regarding the posting and transfer of the petitioners. However, the said case file has since been returned unattended, i.e., without any directions or orders concerning the adjustment or place of posting of the petitioners.

As such, keeping in view the facts and circumstances of the case at hand, and also considering the fact that the office of the Superintending Engineer, M&T Circle, HPSEB Ltd., Bilaspur has already been disbanded vide office order dated 22.02.2025, and further in compliance with the directions dated 09.09.2025 passed by the Hon'ble High Court of Himachal Pradesh in CWP No. 14569 of 2025, to ensure payment of regular monthly salary to the petitioners, the following transfer and adjustment orders are hereby issued with immediate effect:
