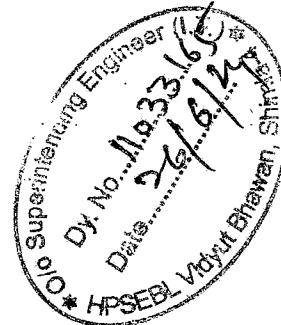

**CWPOA NO. 6100 of 2020-Satinder Kumar Vs. Registrar CSK,
HP Krishi Vishav Vidyalaya- Instructions thereof.**

Sir/madam,

I am directed to refer to the subject cited above and to say that while deciding the aforesaid petition on 29-04-2024, Hon'ble High Court has observed that the Hon'ble Court is flooded with litigations where promotions/appointments etc have been denied solely on the ground of imposition of Model Code of Conduct. The Hon'ble Court has directed the State Government to issue clear instructions regarding the purpose and object of issuing Model Code of Conduct and further to clarify how this document i.e. Model Code of Conduct does not impede the routine working of the Government/Public undertakings/Board/Corporations etc. and further to issue clear instructions that the Model Code of Conduct cannot be used as a pretense by the government servants for indulging in any "un-official pen down strike" during the currency of the Model Code of Conduct.

The Model Code of Conduct is a set of guidelines issued by Election Commission of India from time to time to ensure free, fair and impartial elections by providing level playing field to all political parties and candidates. The guidelines provide clear Do's and Don'ts for the guidance of all stakeholders, clearly delineating the activities/works which can be taken up under intimation to the Election Commission vis-à-vis activities which require prior permission of the Commission. instance, a new work for which tender has been floated, evaluated and awarded; can be started simply with intimation to the Commission. However, in case a tender is to be floated for a new work of emergent nature, prior permission of Election Commission of India is required. Further, in pursuance per ECI letter No 437/6/1/INST/ECI/FUNCT/MCC/2024 dated 16th March, 2024, a Screening Committee headed by Chief Secretary has been constituted and all such proposals of emergent nature are to be recommended by the Screening Committee to the Chief Electoral Officer, Himachal Pradesh for further consideration of the Election Commission of India. As per the instructions in the letter ibid, all such proposals being cleared by the Screening Committee shall carry full justification and a note of urgency, as to why the proposal can't wait till the completion of poll/election. Accordingly, while processing any issue under consideration, the concerned Departments/authorities are requested to examine the same with proper application of mind keeping in view the guidelines with regard to MCC issued by Election Commission of India from time to time.

These instructions be adhered to in letter and spirit.
