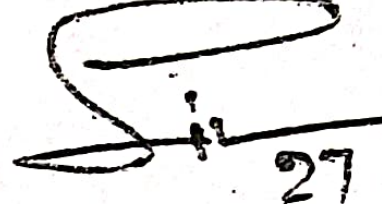

However, the posting orders on promotion of others Section Officers except Sr. 6 shall be issued separately.

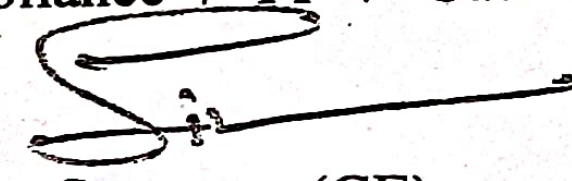

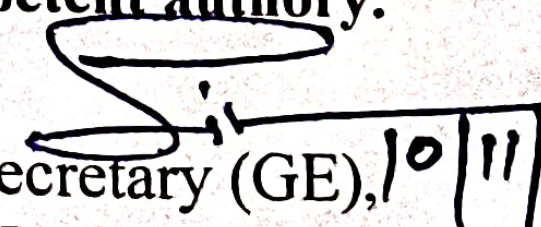

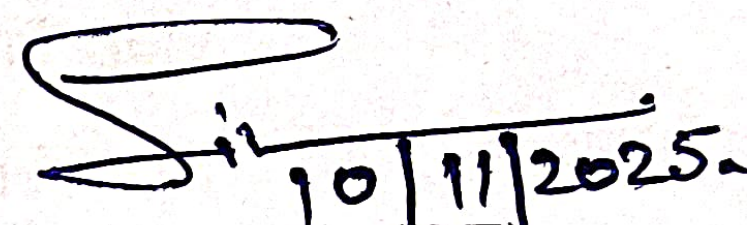
