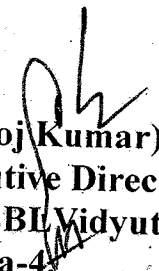

- (i) In each District Electricity Committee, the members i.e. Chairperson/President of the District Panchayat and Most Senior representatives of CPSUs of Ministry of Power and NRE located in the concerned district or their nominated officials for the district is to be considered/nominated by the respective department/office.
- (ii) The Committee will meet periodically at District Headquarters at least once in three months to review and coordinate overall development of power supply infrastructure in the district in

accordance with the schemes of the Government which may, inter-alia, include the following aspects.

- a) All Government of India Schemes, including their progress and quality issues.
 - b) Development of Sub-transmission and distribution network-including regular operations and maintenance of network-identifying further areas where strengthening is needed.
 - c) Impact of the works on quality and reliability of power supply.
 - d) Standards of Performance and consumer services/quality of supply.
 - e) Complaints and Grievance Redressal System.
- (iii) It will be the responsibility of the Convenor and Member Secretary to conduct the meetings on regular basis and issue timely minutes.

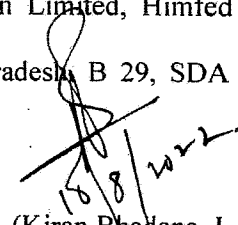
