OFFICE ORDER

No. 52 HPSEBL(SECTT)/2022

Dated:-26.03.2022

WHEREAS the Hon'ble Supreme Court of India vide its order and judgement dated 13.1.2015 passed in Civil Appeal No. 390 of 2015 had directed to provide letter of regular appointment to the Appellants in the aforesaid Civil Appeal being the direct recruitee Assistant Accounts Officers on and w.e.f. the date of their initial engagement treating the initial two years as on probation with further direction to provide the Appellants aforesaid with consequential benefits including regular scale of pay, increment, arrears of pay, seniority etc. to which they are entitled under the law.

AND WHEREAS in pursuance to the judgement dated 13.1.2015 passed by the Hon'ble Apex Court in Civil Appeal No. 390/2015 the direct recruitee Asstt. Accounts Officers were assigned seniority vide Order bearing No. HPSEBL(Sectt)/GE/102-13/2016-12284-12323 dated 9.5.2016 but could not be promoted to the next promotional posts of Accounts Officer(s) as they had not passed the SAS Part-II examination as provided in the Recruitment and Promotions Rules of the cadre of Accounts Officer.

AND WHEREAS the direct recruitee Assistant Accounts Officers challenged the said provision of the R & Regulations of the cadre of Accounts Officers by filing CWPOA No. 11/2019 titled Arjun Singh & Ors Vs State of HP & Ors and CWPOA No. 12/2019 Vipin Kumar and Ors Vs State of H.P. & Ors

AND WHEREAS the Hon'ble High Court of HP vide its order and judgement dated 4.3.2020 allowed the aforesaid CWPOAs filed by the Petitioners-directly recruited Asstt. Accounts Officers and the words " must have passed SAS Part-II" prescribed against 80% promotion quota for promotion to the post of Accounts Officers vide order dated 2.1.2020 was

ordered to be read down and made applicable to the category of Superintendents (D/A) promoted as AAOs against 20% promotion quota prescribed for promotion from those Superintendents (D/A) who could not pass SAS Part-II examination and consequently promotions of Asstt. Accounts Officers, junior to the Petitioners vide orders dated 7.9.2010, 20.7.2012, 28.11.2013, 3.3.2014, 25.11.2014, 9.5.2016 and 7.11.2016 were set aside and Respondents-Board was directed to consider the Petitioners for promotion to the post of Accounts Officers from the due dates from which persons junior to them in the cadre of Asstt. Accounts Officers were promoted pursuant to the DPC held on 28.8.2010 with all consequential benefits.

AND WHEREAS the judgement dated 4.3.2020 passed by the Hon'ble High Court of HP at Shimla in CWPOA No.11/2019 and CWPOA No.12/2019 and CMP No. 7984 of 2019, was further assailed by the promotee Respondents before the Hon'ble Supreme Court of India at New Delhi by means of SLP which was converted into Civil Appeal No.s 6649-6650 of 2021 titled as Ramesh Kumar & Ors etc. Vs State of HP & Ors etc.. The HPSEB Ltd. also assailed the judgement dated 4.3.2020 passed by the Hon'ble High Court of HP at Shimla by means of SLPs which were converted into Civil Appeal No. 6652 of 2021 titled as Himachal Pradesh State Electricity Board Limited Vs Arjun Singh & Ors and Civil Appeal No. 6651 of 2021 titled as Himachal Pradesh State Electricity Board Limited Vs Vipin Kumar Kaushal & Ors.

AND WHEREAS the Hon'ble Apex Court vide its common order and judgement dated 13.11.2021 dismissed the appeals aforesaid. The Hon'ble Apex Court in para 8.3 of its order and judgement dated 13.11.2021 observed as under:

" Now, so far as the prayer on behalf of the Appellants that they may not be reverted is concerned, the aforesaid cannot be accepted. If such a prayer is granted in that case, the effect of the impugned judgement and order passed by the High Court with which we agree shall be nullified. As a necessary consequence to the impugned judgement and order passed by the High Court, now the entire list for the promotion to the post of AO will have to be re-shuffled and the cases of the direct recruits are required to be considered for promotion to the post of AO from the date on which their junior came to be promoted on the post of AO. Therefore, necessary consequences will have to be followed.

AND WHEREAS the HPSEB Ltd has also filed Review Petitions being the RP No. 238 /2022 and RP No. 239/2022, which also came to be dismissed by the Hon'ble Apex Court vide its order and judgement dated 2.3.2022.

NOW, THEREFORE, in compliance to the judgement dated 13.11.2021 passed by the Hon'ble Apex Court in Civil Appeal Nos. 6649-6650 of 2021 titled as Ramesh Kumar & Ors etc. Vs State of HP & Ors etc. and Civil Appeal No. 6652 of 2021 titled as Himachal Pradesh State Electricity Board Limited Vs Arjun Singh & Ors and Civil Appeal No. 6651 of 2021 titled as Himachal Pradesh State Electricity Board Limited Vs Vipin Kumar Kaushal & Ors read with order and judgement dated 4.3.2020 passed by the Hon'ble High Court of HP and as per recommendations made by the Review DPC in its meeting held on 24.3.2022, as also taking into account the vacancy position seniority & R & P Rules are hereby orders as under:

1. The promotions orders of the persons junior to the Petitioners in CWPOAs No.11/2019 and CWP No. 12/2019, issued vide order dated 7.9.2010, 20.7.2012, 28.11.2013, 3.3.2014, 25.11.2014, 9.5.2016 and 7.11.2016 having been quashed and set aside by the Hon'ble High Court vide its order and judgement dated 4.3.2020 together with the orders of adhoc promotions of promotees to the post of CAO/CA, Dy.CAO/CA, Sr. AOs/ AOs and AAOs issued vide order dated 22.3.2021, 26.3.2021, 5.7.2021, 6.8.2021, 22.9.2021 are hereby withdrawn.
2. The direct recruitees and promotee Assistant Accounts Officers are hereby re-positioned in the cadre of AAOs/ AOs/Sr.AOs/Dy.CAO/CA and CAO/CA from the year 2009 onwards till date by reviewing all the DPC from the year of 2010 and considered for their further promotion to the post of Accounts Officers/ Sr. Accounts Officers/ Dy. Chief Accounts Officer/Dy. Chief Auditor and Chief Accounts Officer/ Chief Auditor in the F&A Wing of the HPSEB Ltd. as under:

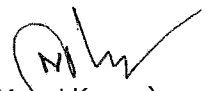
