“ORDER”

WHEREAS, the petitioner namely Sh. Pankaj Thakur presently serving as Junior Engineer (Elect.) at Elect. Sub-Divn. Dharampur, under Elect. Divn. Parwanoo had filed a CWP No. 9351 of 2025 before the Hon'ble High Court of HP against his transfer order dated 2.6.2025 issued by the competent authority of the HPSEBL.

AND WHEREAS, the aforesaid CWP came up for hearing before the Hon'ble High Court of HP at Shimla on 5.6.2025 and the same was disposed of by the Hon'ble High Court of HP with the following directions:-

4.“ Having taken note of the fact that petitioner remained posted within the vicinity of 20-25 kms for the last three years, there appears to be no justification for this court to interfere in the impugned transfer order and as such, same is upheld, however, having taken note of the adverse family circumstances, as were apprised to this court during proceedings of the case, liberty is reserved to the petitioner to file representation within two days to the competent authority for his adjustment at convenient station, which in turn shall be decided by the competent authority within one week taking note of the transfer policy, which certainly enables an employee to seek transfer on the ground of adverse family circumstances. Till the time representation is decided by the competent authority, impugned transferred order shall be kept in abeyance qua the petitioner only. In the aforesaid terms, present petition is disposed of along with pending application (s). if any.

AND WHEREAS, In compliance with the directions dated 05.06.2025 passed by Hon'ble Court of HP, the petitioner has submitted his representation dated 09.06.2025. As such keeping in view the directions dated 05.06.2025 issued by the Hon'ble High Court of HP as well as the averments made by the petitioner in his representation, the competent authority of the Board proceeds to decide the representation of the Petitioner as follows:

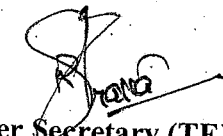
1. It is asserted by the petitioner that he is presently working as a Junior Engineer at HPSEBL Sub-Division, Dharampur, District Solan, Himachal Pradesh, Since 01.01.2024 and was transferred to HPSEBL Sub-Division, Kunihar vide Office Order No. 59 / HPSEBL (SECTT) /2025 dated 02.06.2025. The petitioner has further averred that he has served only 17 months at his current place of posting.

2. He has also stated that his wife is working as a Junior Engineer (Electrical) in HPSEBL Division, Solan, and that they have an 8-month-old daughter. It is submitted that petitioner's wife had C-Section and, due to the absence of any other family support-since his parent reside at their native place in District Mandi- he is the sole caregiver for both his wife and infant daughter. The petitioner has also submitted that he has filed a writ petition before Hon'ble High Court of Himachal Pradesh challenging the aforesaid transfer order, in which the Hon'ble Court has been pleased to direct maintenance of status quo and has further directed the petitioner to submit a representation before the competent authority for reconsideration of the impugned transfer order. It has also been submitted that the petitioner was earlier transferred from HPSEBL Division Solan to HPSEBL Division Parwanoo and was directly reporting to the Executive Engineer, HPSEBL Division Parwanoo. The distance between these offices is more than 40 kilometers, therefore, the allegation regarding the inter-office distance being only 20-25 kilometers is incorrect. In view of the above, the petitioner has requested that the impugned transfer order be cancelled and he be allowed to continue at his preset place of posting.

2. The representative of the concerned admin. section is also heard and it was stated by him that the as per clause No. 3 (a) of Transfer Policy for the time being in force in HPSEB Ltd. The request of the petitioner herein can be considered and his transfer order dated 05.06.2025 can be cancelled and adjusted at the present place of posting.

As such, keeping in view the facts and circumstances of the case at hand as well as the directions issued by the Hon'ble High Court of Himachal Pradesh dated 05.06.2025 in CWP No. 9351 of 2025, decided on 05.06.2025, the request of the petitioner has been duly considered. Accordingly, the office order dated 02.06.2025 is hereby cancelled and recalled and he is ordered to be posted in the same station i.e. at Elect. Sub-Division, Dharampur under Elect. Divn. HPSEB Ltd. Parwanoo.

The representation of the petitioner is decided in the aforesaid terms.

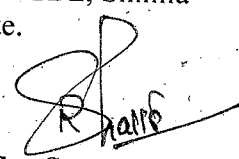
