Matter was listed today for admission hearing.

The Complainant informs that this matter is regarding metering issue as a result of which demand notice dated 12.09.2024 for Rs.11,41,286/- (Annexure C-4) has been raised upon Complainant. Complainant also submits copy of bill dated 05.11.2024 for Rs. 15,45,176/- and disconnection notice of 15 days dated 17.11.2024 which are taken on record. In terms of this disconnection notice the amount payable is Rs.15,45,178/-.

Complaint is accompanied with Application for grant of Interim Stay. Authorised Representative of the Complainant presses for the same and is willing to pay 1/3rd of the disputed amount of Rs. 11,41,286/- amounting to Rs. 3,80,429/-.

Counsel for Respondent is also present and consents to grant Interim Stay on deposit of the said 1/3rd amount.

Complaint is admitted.

Complainant is directed to deposit the said Rs. 3,80,429/- on or before 09.12.2024 with the Respondent.

On deposit of the said 1/3rd amount of Rs. 3,80,429/- on or before 09.12.2024, the operation of ibid demand notice dated 12.09.2024 shall be stayed automatically and no coercive action shall be taken against the Complainant.

On the next date of hearing, Complainant shall submit proof of the deposit of the said amount of Rs. 3,80,429/-

In the event the Complainant fails to deposit the said 1/3rd amount, the Respondent shall be at liberty to take action as per extant Regulations/law.

The Application for Interim Stay is accordingly disposed. Complainant is also directed to not withhold payment of undisputed part of bills which the Forum observes from bill dated 05.11.2024 is not being paid by the Complainant on non-payment of the undisputed part of bill(s) by Complainant, the Respondent also shall be at liberty to take action as per extant Regulations.

Main complaint to come up for Reply on or before 18.12.2024.
