Subject:- Grant of Minimum wages/Revise Rate of wages to the employees of various categories deployed on outsourcing basis in the different units of the Board Ltd. as per HP Govt notification.

Sir,

In this context, it is informed that recently minimum wages/ revise rates of wages of daily wage worker /worker engaged on part time basis and workers hired on outsourced basis working in the different units of the Board Ltd. have been granted as per HP Govt notification No. Fin-(PR)B(7)-33/2010 Govt of HP finance (Pay Revision) department dated Shimla 171002 dated 16th April 2018 and further adopted vide this office order endorsed No. HPSEBL (Sectt) IR-7-5A/Vol-XI/2018-37992-38172 dated 25-07-2018.

It is further intimated that it was decided to release at least minimum wages/ revise rate of wages in future to the outsourced employees working in the various units of the Board Ltd as per Govt Notification as well as adopted by the HPSEBL from time to time and it was further decided that arrear will be reimbursed to contractors after production of actual bill/proof for release of enhanced wages to outsource employees.

Now, the minimum wages of the daily wages/ Part time worker and out sourced worker has been revised w.e.f. 1st April 2019 vide Govt No. Fin-(PR)B(7)-33/2010 Govt of HP Finance (Pay revision) department dated Shimla 171002 the 20th February 2019 and further adopted in HPSEBL vide this office order No. HPSEBL (Sectt) IR-7-5A/Vol-XI/2018 -13675-855 dated 12-06-2019.

Therefore, you are requested to release at least minimum wages/revise rates of wages to the outsourced employees as per latest
