Subject:- Appointment of Liaison Officer for work relating to reservation for schedule castes and scheduled tribes in services.

In this context, it is to inform that Shri Pyar Chand Deputy Secretary (General) in the administrative Wing of the Board Secretariat has been appointed as Liaison Officer to implement the policy/instruction of the Govt. of Himachal Pradesh relating to reservation for Scheduled Caste & Scheduled Tribes etc. vide this office order No. endorsement No.HPSEBL (SECTT.) /R&E / Mise/Govt. Instt./2021-29723-65 dated 26-07-2021 .

It has been come to notice of the higher authority that reservation rosters have been maintained only by some of the cadre

controlling authorities /office(s), whereas various cadre controlling authorities have not yet been maintained reservation rosters and have neither checked by the Liaison Officer/Sub-Liaison Officer who had appointed for this purpose while conduct the Department Promotion Committee nor signed by the Liaison Officer /Sub-Liaison Officer which amounts to flouting of Government/Board's orders.

It is, therefore, requested to appoint Sub-Liaison Officer in each cadre controlling authorities if not appointed and implement the policy /instructions of the Gohp duly adopted by the HPSEBL relating to above cited matter in its letter and spirit in respect of yours cadre controlling office(s). He/ She will be held directly responsible for its implementation and action will be taken against erring officer under the conduct rules for non-compliance of these instructions.

All concerned Officers/officials shall adhere to the aforesaid instructions in letter and spirit. Any deviation of this regard will be viewed seriously.
