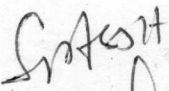

Sir/Madam,

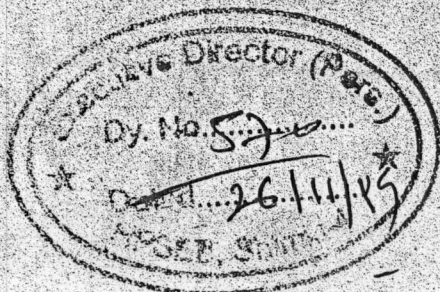
I am directed to refer to the subject noted above and to say that H.P. Ex-Servicemen Corporation 'HIMPESCO' is a H.P. State Government Undertaking under the provision of H.P. Ex-Servicemen Corporation Act, 1979 as amended vide Act, 2013 (passed by the Legislative Assembly of the State). The Government of Himachal Pradesh has nominated HIMPESCO as a Nodal Agency to sponsor security and other services of ex-servicemen to Govt. Departments/Boards/Corporations/State PSUs/Establishments. However, it has been seen that most of the Govt. Deptts/Boards/Corporations/State PSUs/Establishments are not complying with above directions and are not outsourcing Security and other services through HIMPESCO.

Keeping in view of the position stated above, it is reiterated that all Government Departments/ Boards/Corporations/State PSUs/ will ensure to accord first preference in sending the requisition for security services and other services to the H.P. Ex-Servicemen Corporation, Hamirpur and the Chairman-cum-Managing Director of the said Corporation will sponsor the names of suitable Ex-servicemen for Security services and other services from the data bank of Ex-servicemen maintained by the Corporation on receipt of demand/requisition from various quarter concerned.
