ORDER

WHEREAS the petitioner namely Sh. Sanjeev Kumar S/O Late Sh. Bahadur Singh R/O Village and Post Office Poshna, Tehsil Nirmand, District Kullu, HP presently posted as Assistant Engineer (Electrical) in the office of Resident Engineer, Bhaba Power house Division, HPSEBL, Bhabanagar District Kinnaur had filed a CWP No. 12848 of 2025 titled Sanjeev Kumar Vs HPSEBL & another before the Hon'ble High Court of HP praying inter-alia therein for the following reliefs:-

- a. **That the respondents may kindly be directed to transfer the petitioner from his present place of posting i.e office of Resident Engineer Bhaba Power house Division, HPSEBL, Bhabanagar District Kinnaur (tribal area) to one of the stations of his choice as mentioned in Para No.4 supra as well as Annexure-P-1 as per clause 16.1 of the transfer policy within a time bound period. Etc etc**

AND WHEREAS, the Civil Writ Petition aforesaid came up for hearing before the Hon'ble High Court of HP at Shimla on 25-08-2025 on which date, the Hon'ble Court has been pleased to dispose of the petition with the following orders/directions:-

- "3. The case of the petitioner is that he has already completed his normal tenure in a tribal area and has become entitled for transfer to one of the stations of his choice in terms of the Transfer Policy adopted by the respondent-HPSEBL. Petitioner is stated to have filed his representation, Annexure P-1, which has not been decided till date.**
- 4. Accordingly, the petition is disposed of with direction to respondent No.1 to consider and decide the representation of the petitioner, Annexure P-1, dated 05.07.2025 within three weeks from today strictly in terms of the transfer policy adopted by the respondent-HPSEBL.**

Pending miscellaneous application(s), if any, also stand disposed of."

AND WHEREAS, in compliance to the directions passed Hon'ble High Court of Himachal Pradesh vide order dated 25.08.2025, the petitioner was telephonically directed to submit five stations of his choice, so that his representation could be considered in terms of aforesaid orders and judgment dated 25.08.2025 passed by the Hon'ble High Court as well as the transfer policy for the time in vogue in the HPSEBL.

AND WHEREAS, in compliance to the aforesaid telephonic directions, the petitioner submitted his representation on 09.09.2025. Accordingly, keeping in view the directions passed Hon'ble High Court of Himachal Pradesh in the aforesaid writ petition, as well as the averments made by the petitioner in his representation, the Competent Authority of the Board hereby proceeds to decide the said representation as under:-

1. The petitioner has asserted in his representation that he has completed his normal tenure in the tribal area, having served under the Resident Engineer, Bhaba Power

House Division, HPSEBL, Bhabanagar, from 27.07.2020 to 09.09.2025, i.e., for a period of more than five years, in terms of the Transfer Policy of HPSEBL. Accordingly, he has requested his transfer and adjustment to one of the following stations of his choice:-

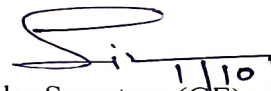
- a.) The Electrical Sub Division (ESD) Larji
- b.) The Resident Engineer, Larji Power House Division HPSEBL, Thalout.
- c.) The Electrical System Division (132KV S/Stn), Bajaura.
- d.) The Electrical Sub.Division (ESD) Nagwain
- e.) The Electrical Sub-Division (ESD) Naggar

2. The representative of the concerned Admin. section was also heard. It has been stated by him that as per the Transfer Policy, the petitioner has completed his normal tenure at his present place of posting i.e. RE Bhaba Power House Division, Bhabanagar and that a substitute is required to be posted in his place. It has further been stated that the petitioner can appropriately be transferred and adjusted at ESD, HPSEBL, Larji, vice Er. Manmohan Singh, Assistant Engineer (Electrical), who is the longest stayee and has not served in the hard/tribal area.

Keeping in view the facts and circumstances of the case at hand, as well as the directions dated 25-08-2025 issued by the Hon'ble High Court of HP in CWP No. 12848 of 2025, the petitioner's request has been considered & allowed. Accordingly, he is ordered to be adjusted and transferred from the office of Resident Engineer, Bhaba Power House Division, HPSEBL, Bhabanagar, District Kinnaur to ESD Larji, vice Er. Manmohan Singh, Assistant Engineer (Electrical) on a vice-versa basis.

Er. Manmohan Singh shall be entitled to usual TTA & joining time, as admissible under rules.
