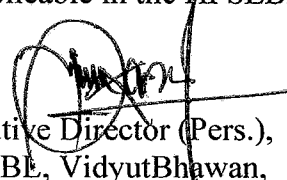

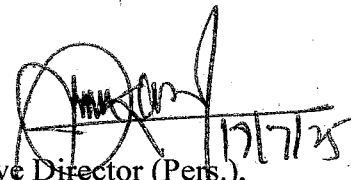

In exercise of the powers conferred by clause (3) of article 166 of the Constitution of India, the Governor, Himachal Pradesh, is pleased to make the following rules further to amend the Business of the Government of Himachal Pradesh (Allocation) Rules, 2021, notified vide Notification No. GAD-C-A(3)2/2019, dated 10<sup>th</sup> December, 2021 and published in the Rajpatra (e-Gazette), Himachal Pradesh, dated 13<sup>th</sup> December, 2021, namely:-
