It is intimated to all that Public Works Department, Government of Himachal Pradesh vide No., PWD-B-F0 (2)/3/2024 (Comp. No. 246544) Dated 12.12.2024, **(copy attached)** has amended the threshold limit for floating e-tender from existing Rs. 5.00 Lakh to Rs. 1.00 lakh.

As mentioned in clause No.52 i, chapter-V (Page No.26) of HPSEBL DELEGATION OF (FINANCIAL, ADMINISTRATIVE AND HR) POWER 2024, it has been enumerated that "This limit has been fixed in line with HPPWD approved practices. As and when any changes in Financial Limit in HPPWD will be implemented, the same shall be followed in HPSEBL in future"

In view of the above, it is hereby directed that the limit for e-tendering shall be Rs. 1.00 Lakh instead of Rs. 5.00 Lakh.
