"ORDER"

WHEREAS, the petitioner **Sh.Vinod Sood** son of **Sh.Gopal Chand Sood** resident of village **Khanlog**, Post Office, **Sholi**, Tehsil, **Nankhari**, Distt. **Shimla** presently working as **Jr.Helper(PHE)** in the office of Resident Engineer **Bhaba Power House Division, HPSEBL, Bhabanagar Distt. Kinnaur, HP** filed a **CWP No.2049 of 2020** before the Hon'ble High Court of HP at Shimla for his transfer from tribal area of **Bhaba Power House Division, Bhabanagar** to any of three stations of his choice viz. **Ghanvi Power House Division, Jeori under (Gen)Circle, Bhabanagar** against vacant post.

AND WHEREAS, the aforesaid civil writ petition came up for hearing before the Hon'ble High Court of HP on **14.7.2020** and the Hon'ble High Court was pleased pass following order as under :-

"The petitioner has been working continuously as Jr.Helper(Electrical) in the hard/tribal area of Distt.Kinnaur posted at the office of Resident Engineer Bhaba Power House, HPSEBL, Bhabanagar, since, 15.5.2017 and has thus completed his normal tenure of two winters and three summers at the present place of posting. That being so, petitioner is entitled to be transferred to a soft area, in terms of the Transfer Policy, but the difficulty is that there is no vacancy available in the stations of his choice opted by him.

2. In this view of the matter, the present petition is disposed of with a direction to the respondents to consider and decide the case of the petitioner as an when vacancy available in any of the three stations of his choice opted by him or in the alternate, the petitioner can submit an additional request to the respondents/ competent authority for considering his case at a station where vacancy is likely to be available and said request shall be considered within a period of two weeks from the date of making such request by the petitioner. The parties are left to bear their own costs. Pending application(s), if any, shall also stand disposed of.

AND WHEREAS, the petitioner submitted a representation on **12.8.20** for implementation of the aforesaid order/judgement of the Hon'ble High Court.

AND WHEREAS, the undersigned has gone through the contents of the petition & representation and it has been observed that the petitioner is

holding the post of Jr.Helper (PHE) at Circle level cadre and working as Jr.Helper (PHE) under Bhaba Power House Division, Bhabanagar w.e.f. 15.5.17 and seeking transfer from Bhaba Power House Division, Bhabanagar to any of three stations of his choice viz. Ghanvi Power House Division, Jeori under (Gen) Circle, Bhabanagar against vacant post i.e. within the same Circle. However, at present non-availability of vacancy in any of three stations of his choice under RE Division, Ghanvi makes it difficult to transfer him. However, as-and-when vacancy becomes available at any of the stations of his choice, his case shall be considered. However, the matter is decided as per the operative part of these order.
